Sub: Extension of affiliation for 2023-24 academic year.

Sir,

- 1) I am pleased to inform you that based on the assessment of inspection report and based on the recommendation of the affiliation committee, the competent authority of this Council has approved extension provisional affiliation of **Maj. Durgamal Subharti College of Hotel Management, Dehradun** for academic year 2023-24 to run **B.Sc. HHA with 60 intake**.
- 2) However, the Institute is advised to install Combi Oven and add more books/e-journals in library.
- 3) The provisional affiliation is initially valid of one academic year i.e. 2023-24, which will be extended/renewed further based on the availability of infrastructure and subject to further inspection by the Council. The Institute will dedicate the campus inspected by the inspection team for running exclusively NCHM course under its affiliation and shall not run any other program of other University.
- 4) The Institute shall follow the admission criteria and fee structure as per the guidelines issued by this Council from time to time.
- 5) Towards signing of the agreement for academic year 2023-24, you are requested to forward two sets of original agreement typed on Rs.100 Indian Non-Judicial stamp duty paper and duly signed by the Chairman of the Institute, latest by 30<sup>th</sup> June 2023, so that one set will be returned to the Institute after signing by the Council's authority.
- 6) You are requested to pay the annual affiliation fee of Rs.1.00 lakh to NCHMCT through DD drawn in favour of NCHMCT payable at Noida, latest by 30.06.2023. In case the amount is transferred through NEFT, particulars of the transaction i.e. UTR No., bank, date, etc. be forwarded to this Council through e-mail at [nchmctadmn@gmail.com](mailto:nchmctadmn@gmail.com) for our verification. Inspection fee of Rs.50,000 has already been received by this Council through DD of Axis Bank.
- 7) The Institute will follow the instructions already given by this Council towards maintaining of Practical Log Book and Summary Sheet. The Council may ask for a copy of the same for verification or to be verified by the academic audit team at any time during the academic year 2023-24.
